#### Points to be noted:

- 1. For UG Courses, students securing 60% or above marks in HS or equivalent examination 2018 are eligible for the award of full-free studentship. Girl students securing 50% marks in the last HS or equivalent examination passed are eligible for half-free studentship.
- 2. For PG Courses, students having First Class are eligible for the award of full-free studentship. Girl students securing 50% marks in the last BA/BSc examination passed are eligible for half-free studentship.
- 3. Poor and distressed students are also eligible for the awards within the limit of 10% of the roll strength.
- 4. Selection of the awards of fee-concession will be based strictly on the basis of merit of the student and financial condition of his/her family subject to approval from Director of Public Instruction, Govt of West Bengal.
- 5. For the fee-concession application, students should submit 02 (two) sets (copies) of the proforma with the following documents enclosed as stated:
