Guidelines for the Creation of the Internal Quality Assurance Cell (IQAC) and Submission of Annual Quality Assurance Report (AQAR) in Accredited Institutions

Introduction

In pursuance of its Action Plan for performance evaluation, assessment and accreditation and quality upgradation of institutions of higher education, the National Assessment and Accreditation Council (NAAC), Bangalore proposes that every accredited institution should establish an Internal Quality Assurance Cell (IQAC) as a quality sustenance measure. Since quality enhancement is a continuous process, the IQAC will become a part of the institution's system and work towards realisation of the goals of quality enhancement and sustenance. The prime task of the IQAC is to develop a system for conscious, consistent and catalytic improvement in the overall performance of institutions. For this, during the post-accreditation period, institutions need to channelize its efforts and measures towards promoting the holistic academic excellence including the peer committee recommendations.

The guidelines provided in the following pages will guide and facilitate the institution in the creation and operation of the Internal Quality Assurance Cell (IQAC). The work of the IQAC is the first step towards internalization and institutionalization of quality enhancement initiatives.

Its success depends upon the sense of belongingness and participation in all the constituents of the institution. It will not be yet another hierarchical structure or a record-keeping exercise in the institution. It will be a facilitative and participative voluntary system/unit/organ of the institution. It has the potential to become a vehicle for ushering in quality enhancement by working out planned interventionist strategies by IQAC to remove deficiencies and enhance quality like the "Quality Circles" in industries.

IQAC – Vision

To ensure quality culture as the prime concern for the Higher Education Institutions through institutionalizing and internalizing all the initiatives taken with internal and external support.

Objective

The primary aim of IQAC is

- To develop a system for conscious, consistent and catalytic action to improve the academic and administrative performance of the institution.
- To promote measures for institutional functioning towards quality enhancement through internalization of quality culture and institutionalization of best practices.

Strategies

IQAC shall evolve mechanisms and procedures for

- a) Ensuring timely, efficient and progressive performance of academic, administrative and financial tasks:
- b) Relevant and quality academic/ research programmes;
- c) Equitable access to and affordability of academic programmes for various sections of society;
- d) Optimization and integration of modern methods of teaching and learning;
- e) The credibility of assessment and evaluation process;
- f) Ensuring the adequacy, maintenance and proper allocation of support structure and services;
- g) Sharing of research findings and networking with other institutions in India and abroad.

Functions

Some of the functions expected of the IQAC are:

- a) Development and application of quality benchmarks
- b) Parameters for various academic and administrative activities of the institution;
- c) Facilitating the creation of a learner-centric environment conducive to quality education and faculty maturation to adopt the required knowledge and technology for participatory teaching and learning process;
- d) Collection and analysis of feedback from all stakeholders on quality-related institutional processes;
- d) Dissemination of information on various quality parameters to all stakeholders;
- e) Organization of inter and intra institutional workshops, seminars on quality related themes and promotion of quality circles;
- f) Documentation of the various programmes/activities leading to quality improvement;
- g) Acting as a nodal agency of the Institution for coordinating quality-related activities, including adoption and dissemination of best practices;
- h) Development and maintenance of institutional database through MIS for the purpose of maintaining /enhancing the institutional quality;
- i) Periodical conduct of Academic and Administrative Audit and its follow-up
- j) Preparation and submission of the Annual Quality Assurance Report (AQAR) as per guidelines and parameters of NAAC.

Benefits

IQAC will facilitate / contribute to

- a) Ensure clarity and focus in institutional functioning towards quality enhancement;
- b) Ensure internalization of the quality culture;
- b) Ensure enhancement and coordination among various activities of the institution and institutionalize all good practices;
- c) Provide a sound basis for decision-making to improve institutional functioning;
- d) Act as a dynamic system for quality changes in HEIs;
- e) Build an organised methodology of documentation and internal communication.

Composition of the IQAC

IQAC may be constituted in every institution under the Chairmanship of the Head of the institution with heads of important academic and administrative units and a few teachers and a few distinguished educationists and representatives of local management and stakeholders.

The composition of the IQAC may be as follows:

- 1. Chairperson: Head of the Institution
- 2. Teachers to represent all level (Three to eight)
- 3. One member from the Management
- 4. Few Senior administrative officers
- 5. One nominee each from local society, Students and Alumni
- 6. One nominee each from Employers /Industrialists/Stakeholders
- 7. One of the senior teachers as the coordinator/Director of the IQAC

The composition of the IQAC will depend on the size and complexity of the institution, accordingly the representation of teachers may vary. It helps the institutions in planning and monitoring. IQAC also gives stakeholders or beneficiaries a cross-sectional participation in the institution's quality enhancement activities. The guidelines given here are only indicative and will help the institutions for quality sustenance activities.

The membership of such nominated members shall be for a period of two years. The IQAC should meet at least once in every quarter. The quorum for the meeting shall be two-third of the total number of members. The agenda, minutes and Action Taken Reports are to be documented with official signatures and maintained electronically in a retrievable format.

It is necessary for the members of the IQAC to shoulder the responsibilities of generating and promoting awareness in the institution and to devote time for working out the procedural details. While selecting these members several precautions need to be taken. A few of them are listed below:

- It is advisable to choose persons from various backgrounds who have earned respect for integrity and excellence in their teaching and research. Moreover, they should be aware of the ground realities of the institutional environment. They should be known for their commitment to improving the quality of teaching and learning.
- It is advisable to change the co-ordinator after two to three years to bring new thoughts and activities in the institution.
- It would be appropriate to choose as senior administrators, persons in charge of institutional services such as library, computer center, estate, student welfare, administration, academic tasks, examination and planning and development.
- The management representative should be a person who is aware of the institution's objectives, limitations and strengths and is committed to its improvement. The local society representatives

should be of high social standing and should have made significant contributions to society and in particular to education.

The role of the Coordinator

The role of the coordinator of the IQAC is crucial in ensuring the effective functioning of all the members. The coordinator of the IQAC may be a senior/competent person with experience and exposure in quality aspects. She/he may be a full-time functionary or, to start with, she/he may be a senior academic /administrator entrusted with the IQAC as an additional responsibility. Secretarial assistance may be facilitated by the administration. It is essential that the coordinator may have sound knowledge about the computer, data management and its various functions such as usage for effective communication.

Operational Features of the IQAC

Quality assurance is a by-product of ongoing efforts to define the objectives of an institution, to have a work plan to achieve them and to specify the checks and balances to evaluate the degree to which each of the tasks is fulfilled. Hence devotion and commitment to improvement rather than mere institutional control is the basis for devising procedures and instruments for assuring quality. The right balance between the health and growth of an institution needs to be struck. The IQAC has to ensure that whatever is done in the institution for "education" is done efficiently and effectively with high standards. In order to do this, the IQAC will have to first establish procedures and modalities to collect data and information on various aspects of institutional functioning.

The coordinator of the IQAC will have a major role in implementing these functions. The IQAC may derive major support from the already existing units and mechanisms that contribute to the functions listed above. The operational features and functions discussed so far are broad-based to facilitate institutions towards academic excellence and institutions may adapt them to their specific needs.

The institutions need to submit yearly the Annual Quality Assurance Report (AQAR) to NAAC by end of September every year positively. A functional Internal Quality Assurance Cell (IQAC) and timely submission of Annual Quality Assurance Reports (AQARs) are the Minimum Institutional Requirements (MIR) to volunteer for second, third or subsequent cycle's accreditation. During the institutional visit the NAAC peer teams will interact with the IQACs to know the progress, functioning as well as quality sustenance initiatives undertaken by them.

The Annual Quality Assurance Report (AQAR) may be the part of the Annual Report. The AQAR shall be approved by the statutory bodies of the HEIs (such as Governing Council/ Executive Council/Board of Management) for the follow up action for necessary quality enhancement measures.

The IQACs may create its exclusive window tab on its institutional website for keeping the records/files of NAAC, Peer Team Reports, AQAR, and Certificate of Accreditation Outcomes and regularly upload/report on its activities, as well as for hosting the AQAR.

Revised Accreditation Framework

NAAC has launched Revised Accreditation Framework since July, 2017 and hence AQAR format also modified, in cognizance with the new methodology. The tools and parameters are designed in the new AQAR format are in such a way that the preparation of AQAR would facilitate the HEI's for upcoming

cycles of Accreditation. Data collected/prepared infuses quality enhancement measures undertaken during the years. Further, it also adds quality enhancement and quality sustenance measures undertaken in teaching, learning, research, extension and support activities of the Institution. It is hoped that new AQAR would facilitate Educational Institutions for creating a good database at Institutional level for enhancing the quality culture.

As per the Revised Accreditation Framework (RAF), the NAAC Accredited institutions need to submit the AQAR online. NAAC is in the process of ICT integration in Assessment and Accreditation. The login id for the online submission for AQAR submission will be the e-mail id used for the IIQA. The AQAR submission is part of the post accreditation module, in due course of time. NAAC portal will have the facility to submit the AQAR online and Institutions will receive automated response. AQAR of the preceding year be submitted to the NAAC within six months i.e. the institutions should submit the AQAR before 31st December of every year.

The Higher Education Institutions need not submit the printed/hard copy of AQAR to NAAC.

Mandatory Submission of AQAR by IQAC

The Executive Committee of NAAC has decided that regular submission of AQARs is mandatory for 2nd and subsequent cycles of accreditation with effect from 16th September 2016:

The following are the pre-requisites for submission of IIQA for all Higher Education Institutions (HEIs) opting for 2^{nd} and subsequent cycles of A&A:

- Having a functional IQAC.
- The minutes of IQAC meeting and compliance to the decisions should be uploaded on the institutional website.
- Mandatory submission of AQARs on a regular basis for institutions undergoing the second and subsequent cycles of Assessment and Accreditation by NAAC.
- Upload the AQAR's on institutional website for access to all stakeholders.

Note: The terms and abbreviation used in AQAR are in accordance with respective manuals for assessment of NAAC. Please refer institutional manual for glossary and abbreviations terms used in AQAR.

A Web-based admission process has been launched by the college for the session 2018-19 which has ensured complete digitalization of the college admission procedure. The UG departments of the institution follow the syllabus and guidelines of the affiliating university. Several teachers are members of the Undergraduate Board of Studies, where they actively contribute in the university's curriculum forming process.

The PG departments have academic autonomy. They frame their syllabus, with advice from subject experts, which are subsequently approved by the PG BOS. The PG syllabus is included in the PG prospectus.

The Institution has upgraded itself to cope with the demands of the changing syllabi. It uses supports of smart classrooms, ICTs, audio-visual material available on the internet to make a successful implementation of the curriculum. Student seminars and discussion sessions are organised to further the objective of improved communication of the syllabus. Resource persons are also invited to deliver talks and lectures.

All activities of the institution are continually documented through photographs of the events, records of attendance in classes and extracurricular activities. These records are preserved by respective departments and committees. The departments also preserve projects and presentations as part of the documentation.

Notices are published in the general notice book, notice board and the website to inform all stake-holders about an event. They also form a part of the documentation of an event/activity.

- 1.4.2 How the feedback obtained is being analyzed and utilized for overall development of the institution? (maximum 500 words)
- 1) Regular feedbacks are taken from students by the departments. The feedback is read by all the teachers of the department. Thereafter the feedback is centrally analysed and addressed (or redressed).
- 2) Teachers' council meetings must be regarded as a well documented feedback taking platform. Teachers both give and resolve issues in these meetings about every academic activity.
- 3) Since ours is a government institution, the institution submits regular reports to the government about all its activities and it functions according to government rules and instruction. The Government send its nominees and representatives to procure further information, if so required.
- 4) The college has a strong and effective alumnus. Some of the regular teachers being alumni-members act as liaison-officers exchanging information between the alumnus and the institution.
- 5) The departments also organise Parent-Teacher meetings. These meetings are very effective platforms for teachers to give their feedbacks to the parents about their wards and the facilities that are enjoyed by students in this college. 2.3.2 Students mentoring system available in the institution? Give details. (maximum 500 words)

Various systems are in place for mentoring students in this institute. The majority of students of this institute come from lower middle class or economically poor households. Many of them are 1st generation learners with no academic environment at home. Keeping this backdrop in mind, the institute has devised a number of systems to cater for the academic and overall development of the student. Each department holds regular tutorial classes (at least 4 per week), remedial class for socially and economically vulnerable students after college hours. Initially the remedial classes were funded by UGC, but the college continued with the practice even when the funds were discontinued. A psychological counselling cell is functional in the college which regularly provides mental support to the students. It organises regular awareness programs and workshops aimed at personality development and gender sensitization. Student seminars are also organized to hone their speaking and presentation skills.

6.2.1 Quality improvement strategies adopted by the institution for each of the following (with in 100 words each):

Curriculum Development:

The College is affiliated to West Bengal State University currently, for the under-graduate courses. The department has little role to play in designing the UG course curriculum, structure or examination pattern. However several faculty members of our college belong to the UG and PG board of studies and hence play an active role in syllabus designing. In the Post-graduate departments there is scope under the present system to function outside the purview of the affiliating university. The main salient feature of syllabi of all P.G. departments is to include dissertation, presentation in the part of the core curricula encouraging the mastering of research and analytic writing skills. The entire PG syllabus is remodelled biennially in PG Board of Studies meeting, whereby all recent developments in the discipline are incorporated in the PG syllabus.

Teaching and Learning:

- > ICT enabled teaching-learning process is encouraged.
- Film-shows, Quiz etc. related to curricula are organised by all the departments.
- ➤ Interactive teaching-learning process is adopted.
- Educational excursions are conducted by some departments.
- > The post graduate department provides ample infrastructure for pursuing research work on different specialized branches. The assembly of carefully chosen instruments often combined with analytical software in different laboratories assure training and accessibility to a wide range of pupils from undergraduate level to researchers.

***** Examination and Evaluation

Since the college is affiliated to the West Bengal State University, it does not have academic autonomy to design examination pattern or evaluation procedure for the undergraduate courses. However the departments design regular internal exams, weekly tests, quiz and students seminar to assess students' academic progress.

The three Pg departments of the college enjoy academic autonomy in designing examination and evaluation methodologies in semester pattern. Examination pattern includes semester exams, practical tests, student presentation and dissertations

* Research and Development

- 1. The institution continues to support and encourage the teachers in their research endeavours through a Research Committee comprising of senior faculty members.
- 2. Institutional support is provided to enable implementation of research schemes in the following ways:
 - i. Full autonomy is given to the Principal investigator for smooth conduct of the research project.
 - ii. Funds sanctioned by the different agencies are released without delay as and when required by the researcher.

7.1.7 Initiatives taken by the institution to make the campus eco-friendly (at least five)

a. Energy conservation:

The concern for energy conservation prevails among both the staff and the students. At the end of the day, all electronic and electrical installations are immediately switched off and the devices are unplugged. Use of AC machines is regulated through awareness programme. The use of generators at the time of power cut and that of the emergency power supply is kept to a minimum. Effort has also been taken to supplant the energy consumable lamps with modern energy saving CFL lamps and tubes. The college uses environment friendly and star rating instruments for moderate consumption of energy.

b. Efforts for Carbon neutrality -

- Using Air conditioners at a fixed higher mode in order to reduce greenhouse gases and thereby mitigate climate change.
- > Judicious use of electricity in the campus by sensitizing the stakeholders.
- > Use of renewable Energy in the form of installation of solar panel photovoltaic system that will result in the reduction of carbon at the college premises.
- > Judicious use of Natural Gas by the Departments of Chemistry and Biological Sciences results in minimum purchase of natural gas

c. Plantation:

Tree Plantation programme is held annually by the NSS Unit. The Department of Botany maintains a Medicinal Plant Garden in the college.

d. Hazardous waste management:

Care is taken to eliminate the production of hazardous waste or minimize the amount of waste for disposal by recycling, reusing and/or recovering the waste, by the departments of chemistry and biological sciences. To reduce the volume of chemical waste generated in the laboratories the following initiatives have been taken:

- a) Purchase of smallest quantity of hazardous chemicals required for our laboratories.
- b) Sharing surplus chemicals with other laboratories of biological sciences.
- c) Purchase of mercury-free instruments.
- d) Substituting hazardous chemicals with non-hazardous chemicals whenever possible.
- e) Reducing the scale of laboratory experiments to reduce the volume of wastes being produced as and when possible.

Apart from these, we have specially constructed a Waste Accumulation Area (WAA) outside the Department of Chemistry to dispose the waste. The waste is passed through a pipeline to the WAA.

- Thus the institute is in high demand and the demand ratio of the college is 1:8
- To have a transparent merit base admission system, the huge data generated has to be maintained, compiled and analyzed. Hence a totally online admission procedure is the need of the day.
- Applicants from distant areas can avail the system online without having to be physically present in the institute.

Practice and Implementation:

- Login to the system through the first page of the application.
- New student registration after logging into the system.
- View/change his/her details.
- Can get help through the help option to view different features of the system.
- Admin login should be present who can read as well as remove any uploads.

College Management Software is web enabled software designed to manage the entire Operations of an institution. It is a simple yet powerful one joint integrated platform that connects all the various departments of an institution like Administration, Account, Student section, Student and many more specialized modules. We have seen over the years that the process of notice boards, important notification about academics has been carried out manually almost across all educational institutions. The process is not only time consuming but also inefficient. Today, we need not to maintain paper based Notice boards. Also in this system we are going to add the web based technology using which we can get the notifications given by the institutes. Following this thought, we have developed a online admission system based on the concept of web services which is implemented on Android mobile application as well as on PC that communicates with the database residing on a remote server. The Unique ID system provides unique identification numbers to the persons who using this system. UID Number which would not just help the admin to track down individuals, but would make life far easier for users as they would not have to submit multiple documents each time because those will be available and to be used.

Best Practice 2

Title of the Practice:

Book bank operating for financially under privileged students

Objectives:

To provide a **Book Bank** for under privileged students who do not have the financial ability to purchase text books.

Context:

- Barasat Government College is located in the district headquarters of North 24 Parganas. It is well connected both by rail and
 road to the large rural hinterland of the district. A good number of students of this college come from the rural or semi-urban
 areas. There is a high rate of enrolment of students of under privileged sections of society, mostly from the SC, ST, OBC and
 Minority community.
- The college provides books to the students both from the main library and departmental library. The maximum number that can be issued from the main library is two and that from the departmental library is three and has to be returned within 15 days of issue.
- Students require specific text books for university examinations. They need these throughout the year. They cannot afford to return these books to the library because they need to consult these anytime for ready reference.
- As many students belong to the economically weaker section of the society, they cannot afford to buy text books as well as

reference books for their academic perusal.

 With this in mind, each department of the college has come up with a unique endeavour of providing text books and some reference books to needy students.

Practice and Implementation:

- The stock of books comes from donations from individual teachers and alumni of the departments. Specimen copies given to the members of the departmental faculty are also added to the already existing stock. Retired teachers also sometimes donate books from their personal library.
- A teacher of the department who is in charge of the seminar library is also in charge of the book. The teacher maintains the issue and book register of the bank.
- The students are asked to apply to the departmental head to avail the book bank facility. A departmental meeting is held to select the students on the basis of their financial capability. The selected students are asked to provide their name, address and contact number.
- The books are issued as per students' requirement for a maximum period of one academic year. They have to return the books after the end of the university exam. Book bank clearance is necessary for the students to collect their final examination marksheet from the college office. This ensures that books are timely returned to the bank.
- The students compensate for any damage to the books.

7.3 Institutional Distinctiveness

Provide the details of the performance of the institution in one area distinctive to its vision, priority and thrust

Barasat Government College is a distinguished premiere institution not only of the district but also of this state. This college was set up, in the year 1950, aiming to impart quality education to the pupils for their all-round development.

As one of the leading colleges of the district, we do our best to ensure quality education. Owing to its geographical location in the communication network, ambiance, glorious records, remarkable results and achievements, the college attracts the best brains of the locality students from a wide area and from a varied socio-economic background. A good number of students of this college come from the rural or semi-urban areas. The high rate of enrolment of students of under privileged sections of society, mostly from the SC, ST, OBC and Minority community is also a significant factor. The ratio of the girl students of the college is also noticeably high.

This social reality gives us more challenging task, and the greatest one may be, of providing the access to higher education to these under-privileged and deserving students. Following the ideals of inclusive education, we are committed to look after the needs of the larger society, including students from this disadvantaged class, who are meritorious but lack the means. So our mission is to prove that even a first generation learner can reach the heights if given proper opportunities, right facilities and guidance.

With reference to the above table it is apparent that the ratio of female students in this college is very high and is steadily increasing over the years. Majority of them belong to financially as well as socially backward classes. A large section of them belong to Muslim minority group. Encouraging these students to pursue higher education and motivating them to continue with their studies braving social

odds proves a challenge to the institution. A number of steps have been devised focussing on the female students of this college:

- (i) A variety of financial scholarships like Kanyashree (a state government scholarship), single girl child scholarship (central govt.), poor fund, half free and full free scholarships are provided to the students through the scholarship committee of the college. The college has temporarily recruited 2 staff members to provide assistance to the girl students regarding this matter.
- (ii) A strong ICC and gender cell, which addresses the various gender related issues, functions in the college. The committees regularly arrange gender sensitization programs to raise awareness on various social issues relating to women.
- (iii) A fully functional psychological counselling cell operates in the institute providing support and guidance to the female students.

8. Future Plans of action for next academic year (500 words)

- The college plans to implement CBCS system as per university regulation and UGC recommendation from the next academic session in the undergraduate courses. IQAC recommends the formation of a CBCS implementation committee formed of faculty members and non teaching staff of the institute who will work in collaboration with the routine committee for smooth implementation of the new system.
- A plan for the introduction of online student management system is underway. This webpage will provide a single portal for the students where their personal information, academic results (both university and internal assessment), attendance details, scholarship data etc. IQAC has suggested that a financial module be provided in the portal so that students can check their dues and make online payment of fees. It also should have an archival facility for storage of students registration certificates, admit cards, mark-sheets etc.
- The existing solar panel has a very limited capability. Extension of this solar panel facility is being hindered due to fund crunch of the institution. Therefore it is suggested that pollution control board of west Bengal may be approached for installation of solar panel to provide alternative source of energy free of cost.
- IQAC has suggested improvement of the vermicompost plant for treatment of biological waste. Non-hazardous wastes, like dead plants, left over food from the canteen etc. are to be collected in a chamber for pre-decomposition by the help of microbes and worms. The vermi-compost so produced may be used as manure or fertilizer for the college gardens.
- NSS is to be asked to extend their activities and improve student particiation
- IQAC has suggested to the principal that the Higher Education Minister may be approached to arrange the adjoining field as a football ground for the college students.
- Renovation of the main and annexe building and Relaying of the damaged floors of the class rooms and chemistry laboratories has been suggested.
