BARASAT GOVERNMENT COLLEGE, BARASAT, the "First Party" represented herein by its Principal as Representative and Competent Authority (Hereinafter referred as "First Party", the institution which expression, unless excluded by or repugnant to the subject or context shall include its successors – in office, administrators and assigns)

BARASAT MUNICIPALITY, BARASAT, the "Second party" and represented herein by the Chairman as Representative and Competent Authority (Hereinafter represented as "Second Party", the institution which expression, unless excluded by or repugnant to the subject or context shall include its successors – in office, administrators and assigns)

(First Party and Second Party are hereinafter jointly referred to as 'Parties' and individually as 'Party') WHEREAS

- A. **FIRST PARTY is a Government Higher Educational Institution named: BARASAT GOVERNMENT COLLEGE, BARASAT, 10, K.N.C. Road, North 24 Parganas, Kolkata -700124**
- B. First Party and Second Party believe that collaboration and cooperation between themselves will promote more effective use of each of their resources, and provide each of them with enhanced opportunities.
- C. The parties intent to cooperate and focus their efforts in cooperation within the area of infrastructural development, sharing of social responsibilities, community awareness generation with best effort, mutual benefit, and frequent interactions.
- D. Both Parties being legal entities in themselves desire to sign this MoU for advancing their mutual interests.
- E. **BARASAT MUNICIPALITY, BARASAT, Rishi Bankim Chandra Road, North 24 Parganas, Kolkata-700124, West Bengal, the Second Party is an Urban Local Body of West Bengal under the aegis of the Department of Urban Development and Municipal Affairs, Government of West Bengal and is engaged in maintaining developmental responsibilities through community participation via elected representatives' and extension thereafter.**
- F. The Second Party presently functions from its own campus at Rishi Bankim Chandra Road, North 24 Parganas, Kolkata-700124, West Bengal, and will continue to do so until further order from the Department of Urban Development and Municipal Affairs, Government of West Bengal. It has no other branch, wing, subsidiaries or extensions existing at present.

NOW THEREFORE, IN CONSIDERATION OF THE MUTUAL PROMISE SET FORTH IN THIS MoU, THE PARTIES HERE TO AGREE AS FOLLOWS:

Clause-I
CO-OPERATION

- 1.1 Both the Parties are united by common interest and objectives, and they shall establish channels of communication and co-operation as far as practicable and to the best of efforts, that will promote and advance-
- Joint involvement towards local area development and urban planning by the partner institutions;
 - Collection and Management of solid and liquid wastes;
 - Organization of social awareness programme;
 - Involving students in community based and promotional activities;
 - Visits by faculty, professional staff and students (including internship) for academic and administrative purpose;
 - Exchange of information on urban development, environment monitoring, population and other matters relevant to their educational and research programmes; Development and maintenance of physical infrastructure at the college campus;
 - Any other joint venture for academic and community enrichment of the area on prior agreement of the Principal and Chairman of the concerned institutions; within the Institution and its related wings.
- 1.2 Both the Parties shall keep each other informed of potential opportunities and shall share all information that may be relevant to secure additional opportunities for one another.
- 1.3 A slum "SARADAPALLY, WARD NO.-29, Barasat Municipality" which was earlier adopted by NSS, Barasat Government College on and from 20/06/2022, is further adopted here in extension by the NSS and the college as a whole along with "WARD NO.-13, WARD NO.-29, Barasat Municipality". These are adopted by the college for some related activities for the next five years.
- 1.4 First Party and Second Party must respect each other's intellectual property and the disputes if any, relating to any aspect social cooperation, the head of the institution (Principal/ Chairman) of both the Organization will jointly resolve the dispute in a spirit of independence, mutual respect, and shared responsibility.
- 1.5 Both the Parties mutually agreed not to include any financial transaction during the execution of this MoU.

- 1.6 Neither Party shall be held responsible for non-fulfillment of their respective obligation under this MoU due to circumstances beyond their control but not limited to pandemic, war, flood etc. If such condition continues beyond six months, the parties shall then mutually decide about the future course of action.
- 1.7 Nothing in this MoU shall be construed to make either party a partner, an agent or legal representative of the other for any purpose. Now onwards both the party may mention the name and LOGO of the other in their documents as "COLLABORATOR" for purpose as may be required subject to communication by the user to the other party in writing beforehand.
- 1.8 This MoU unless terminated by mutual written agreement will continue for 5 years after the effective date specified in the opening paragraph and can be renewed through mutual interest. Either Party shall have the right to unilaterally terminate this MoU 90 days prior written notice to the other party.
